have secured minimum 55% in M. Sc. Physics

7. **Desirable qualifications** Candidates with experience in C++ programming, particle or detector

simulations with GEANT4 simulation toolkit and ROOT will be preferred.

8. Duration of the fellowship 1 year, extendable by another 2 years subject to satisfactory performance as

evaluated by the PI and release of funds by the agency.

9. Fellowship amount Rs. 25,000/- + HRA* as applicable (as per rules and regulations of DST)

Application Procedure: Interested eligible candidates should send their CV along with latest photograph, scanned copy of their educational qualifications and a statement of interest by email to deepaksamuel@cuk.ac.in on or before 08-10-2017 The short listed candidates will be notified for personal interview by email only. TA/DA is not admissible for attending the interview or for joining the post.

*for candidates not possessing NET-JRF, the fellowship will be lesser and will decided by the rules and regulations at the time of appointment.

GENERAL INFORMATION

1. These positions are purely on contract and temporary.

2. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the

same will not entitle him/her for being called for interview. The University reserves the right to restrict the

candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher

than the minimum prescribed, or by any other condition that may deem fit.

It would be open to the University to consider the names of suitable persons who may not have applied, but

recommended by experts in their respective fields.

4. The statutory provision for relaxing of age, experience etc. prescribed in case of the candidates belonging to

SC/ST/OBC/PH categories will be made applicable to them as per UGC / GOI norms in force at time of interview.

6. The University may offer lower post to a candidate who may have applied for a higher post in case suitable
