I also agree to refund one half of the advance if the return journey could not be performed within 90 days from the date of advance. I also agree to credit forthwith to the office any excess amount of advance left with me for any reason whatsoever.

I also agree to produce evidence of purchase of tickets, etc for myself/members of my family, as the case may be, for the forward journey within 30 days or before the commencement of the journey whichever is earlier from the date of drawing the advance.
