- 4. Technical literature/brochures of the quoted model explaining all specifications including circuit diagrams should be enclosed with the quotation should be uploaded. Detailed operational manual (both electronic and printed versions) should be provided with the equipment. All the documents should be in English.
- 5. The supplier must provide guarantee that all the specifications being offered shall be demonstrated to conformity with the values in quotation while installation. The supplier must submit a table indicating the compliance of the features of the quoted model with those

- given in quotation (packet 1, Annexure -2). If any feature is not matching, it should be mentioned and explained.
- 6. Minimum **one year warranty** is required on the main equipment and accessories from the date of installation.
- 7. Spare parts should be supplied with the instrument.
- 8. Details of installation, commissioning and training of the equipment must be specified in the brochure or leaflet (could be mentioned in Annexure -1).
- 9. Installation and commissioning should be made by the contractor or its Indian representative. The Indian representative should have well proven service capability on similar systems and should have service engineers trained by manufacturer for after sale support. Details of the service support in terms of service centres with address and telephone number, service engineers with names and experiences, response time during warranty and afterwards should be provided with the offer.
- 10. Proper user training for operation and maintenance of the equipment should be provided at the time of installation.
- 11. Utility and installation requirements (Electrical power, cooling water, compressed air, etc.) should be clearly mentioned in quotation.

Annexure I

Technical Specifications for Atomic Force Microscope

Central University of Karnataka wishes to procure atomic force microscope (AFM) with accessories. Original equipment manufacturers or authorized dealers can submit bids for supply, delivery, installation, testing and commissioning of AFM (as per specifications below) with a list of other accessories required for complete and smooth operation of the equipment. The technical offer should clearly include make and model number of the offered equipment.

Technical Specifications:

1. Operational modes with AFM:

Non-contact and Contact modes for Topography imaging, Phase Imaging, Lateral Force Microscopy (LFM), Electro Static Force Microscopy, Conductive AFM (or current – AFM), force – distance spectroscopy, Current-Voltage spectroscopy and force volume imaging.

Liquid Imaging setup for Bio Samples: A suitable liquid imaging setup consisting of liquid cell, sample holder (if required) and cantilever mount (if required) to be offered for imaging samples in liquid media. The liquid cell must be compatible for electrical measurements done by applying small voltage bias between the AFM tip and sample.

Other modes, which come as default modes with the offered instrument should also be mentioned.

The equipment must be compatible with standard universal cantilevers obtained from third party.

2. Scanners and sample holders:

The scanners and sample holders must be for high resolution imaging. The XY (which moves horizontal directions in the XY plane) and Z scanners (which moves AFM tip the vertical direction) should be mechanically driven by piezoelectric materials for dynamic performance and stationary positioning.

Maximum XY scan range: 9-15 μm or better for high lateral resolution. The XY scan resolution shall be better than 0.05 nm

Z scan range: $10-12 \mu m$. The resolution along the Z axis shall be better than 0.5 nm

3. Manual XY Stage: XY travel range of 1 cm X 1 cm or more.

4. Cantilever – Sample viewing:

AFM cantilever/probe and sample surface should be viewable on axis in real time via direct on-axis optics with high resolution CCD and video access.

5. Controller electronics:

a) The controller must have high performance processing unit.

- b) Signal access ports must be provided to access AFM input/output signals (to monitor photodiode output (LFM signal not mandatory), to drive tip bias and sample bias and to feed analog signal from external devices).
- c) Auxiliary analog signal input port to feed analog signal from external devices
- d) The system should support high pixel density images up to \sim 4000 X \sim 4000 pixels or more
- e) Feedback frequency should be at least 500 kHz or better.

6. Computer and software:

- a) Appropriate computer loaded with compatible hardware and operating system for using the equipment (AFM) efficiently
- b) Dual monitors of size 23 inch or more
- c) Appropriate graphic card must be installed in the computer
- d) Software for data acquisition, image processing and data analysis must be provided

7. Accessories:

- a) Acoustic enclosure
- b) Vibration isolation system
- c) 5 Nos. of cantilevers for contact mode (force constant: 0.2 N/m)
- d) 5 Nos. of cantilevers for non-contact mode (resonance frequency: 60-80 kHz)
- e) 5 Nos. of conducting cantilevers to be used in non-contact mode (resonance frequency: 60-80 kHz)

8. Power and cable requirements

All the power and cable requirements and accessories must be suitable for use in India.
