The candidates with eligible qualification as per UGC norms may attend walk in interview on above mentioned schedule and venue at Central University of Karnataka.

1. The engagement is purely on temporary basis for a period of one semester only. For the engagement on contractual basis, faculty shall be paid a remuneration of Rs.40,000/- for candidates possessing UGC/CSIR- NET/SLET and Rs.45,000/- for candidates possessing UGC/CSIR- NET/SLET along with Ph.D. in the relevant subject.
2. The engaged teacher assistant on Hourly basis shall be paid Rs.1,000/- per hour as per UGC norms.

2.1. Minimum qualifications for appointment - Arts, Humanities, Sciences, Social Sciences, Commerce, Languages, Computer Science (MCA), etc.

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- iii. Notwithstanding anything contained in sub-clauses (i) and (ii) to this Clause 2.1, candidates, who are, or have been awarded with a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions. However, such exemption will be considered upon the

production of certificates from University, which clearly substantiate that Ph.D. degree has been awarded with course work.

- iv. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

2.2 MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHING FACULTY IN UNIVERSITIES -ENGINEERING AND TECHNOLOGY DISCIPLINE:

i. Essential

First Class Master's Degree in the appropriate branch of Engineering (Engg.) & Technology (Tech).

ii. Without prejudice to the above, the following conditions may be considered desirable:

1. Ph.D. in respective subject
2. Teaching, research industrial and / or professional experience in a reputed organization;
3. Papers presented at Conferences and / or in refereed journals.

General Information

1. Reservation for SCs/STs, OBCs and PHs for all posts exists as per the guidelines of the UGC / GOI. Candidates applying for the reserved posts should clearly state to which category they belong. They must also enclose attested Photostat copy of Caste Certificate/ Medical Certificate from the concerned competent authorities. The form of caste certificate to be produced by other backward class candidates must be in the format as prescribed by the Govt. of India (please visit website www.ncbc.nic.in for further details). Otherwise, the application will be summarily rejected without further consideration.
2. Relaxation of 5% marks (55% to 50%) will be provided at the Masters level in the case of SC/ST/PWD, and to those Ph.D. degree holders who have passed their Masters degree prior to 19th September 1991. The eligibility marks of 55% (or an equivalent grade in a point scale, where ever grading system followed) and the relaxation of 5% to the categories mentioned above are permissible based on only the qualifying marks without including any grace marks procedure.
3. Retired teachers, below the age of 65 may also apply.
4. Candidates offered the position will have to join within one week and should produce the original marks cards and testimonials along with address proof at the time of joining.
5. Original grade card / Marks sheet of Ph.D. Course work must be produced wherever applicable.
6. Age qualifications, etc. shall be reckoned as on the last date of submission of application form/date of walk-in-interview.
7. No increment/enhancement of remuneration on account of completion of Ph.D. will be entertained during the period of contract.
8. The University has no compulsion to issue an experience certificate having worked as contract faculty. The work order itself shall be the proof for the such request.
9. The University reserves the right to withdraw any advertised post(s) at any time without giving any reason or change or alter the number of vacancies against any of the posts advertised or not to fill any vacancy.
10. No TA/DA will be paid to the candidates for appearing for the interview. At the time of Interview candidates have to produce the original certificates / testimonials / books / published research papers/etc.
11. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
12. No interim correspondence shall be entertained.

13. Candidates appointed shall not be entitled to claim for any weightage for regular appointment / position in the University at a later date.
14. Candidates are strongly advised to visit the university website regularly www.cuk.ac.in for any addendum, corrigendum and modification etc., in the notifications will be modified on the university website only.
15. Selected candidates must submit a copy of PAN card at the time of joining/ within a period of one month to release the payment.
16. Anything not covered above shall be governed by UGC/MHRD/GOI norms issued from time to time.
