2.1. Minimum qualifications for appointment - Arts, Humanities, Sciences, Social Sciences, Commerce, Languages, etc.

i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.

- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- clause 2.1, candidates, who are, or have been awarded with a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions. However, such exemption will be considered upon the production of certificates from University, which clearly substantiate that Ph.D. degree has been awarded with course work.
- iv. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

2.2. Minimum Qualifications for Appointment - Engineering and Technology

I. Essential

- 1. First Class Master's Degree in the appropriate branch of Engineering (Engg.) & Technology (Tech).
- II. Without prejudice to the above, the following conditions may be considered **Desirable:**

I. Teaching, research industrial and / or professional experience in a reputed organization;

- II. Papers presented at Conferences and / or in refereed journals.
- III. Ph. D. in relevant stream.

2.3. Minimum Qualifications for Appointment - Women's Studies Centre

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level in any subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- iii. Notwithstanding anything contained in sub-clauses (i) and (ii) to this Clause 2.1, candidates, who are, or have been awarded with a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions. However, such exemption will be considered upon the production of certificates from University, which clearly substantiate that Ph.D. degree has been awarded with course work.
- iv. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

General Information

The eligibility marks of 55% (or an equivalent grade in a point scale, where ever grading system followed) and the relaxation of 5% to the categories mentioned above are permissible based on only the qualifying marks without including any grace marks procedure.
- 3. Retired teachers, below the age of 65 may also apply.
- 4. Candidates offered the position will have to join within one week and should produce the original marks cards and testimonials along with address proof at the time of joining.
- 5. Original grade card / Marks sheet of Ph.D. Course work must be produced wherever applicable.
- 6. The University reserves the right to withdraw any advertised post(s) at any time without giving any reason or change or alter the number of vacancies against any of the posts advertised or not to fill any vacancy.
- 7. No TA/DA will be paid to the candidates for appearing for the interview. At the time of Interview candidates have to produce the original certificates / testimonials / books / published research papers/etc.
- 8. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
