**Functions, Powers and duties of ABS:**

- To uphold the commitment of the Central University of Karnataka to provide campus environment free of gender-based discrimination, sexual harassment and other acts of gender-based violence.
- To promote a social and psychological environment which will raise awareness about gender based discrimination and prevent sexual harassment and other acts of gender based violence.
- To generate awareness about gender based discrimination, sexual harassment and other acts of gender based violence.

**Term of office of chairperson and members of ABS and UCC:**

- The chairperson and members shall hold office, as such, for a term of two years from the date on which they assume office.
- Provide that no chairperson or any member shall hold office for more than two terms.

**Procedures for Transaction of Business of ABS:**

- i. The ABS will hold at least five meetings/programmes in an academic year, with not more than 2 months gap between the two meetings.
- ii. Proceedings of all the meetings shall be recorded, confirmed and adopted by the ABS members.
- iii. Any may request the chairperson to call an emergent meeting of the ABS for which at least 24 hours advance notice shall be given. The quorum for the meeting shall be one third members of the ABS.

This order will come into force with immediate effect.
