NATIONAL CONFERENCE: CONTEXT:

As a result of the neoliberal economy, the social transformation has been witnessed in the developing and under-developed societies. India is no exception to this phenomenon. Individual, family, groups, organizations, culture and communities have shown altogether a different pattern. Social change in the behaviour, life style, values, beliefs and practices is drastically observed at varied degrees now, more than ever in any stage of human history, Integrated farm and non-farm economy has emerged due to inadequacies in the rural agricultural system of India

This economic context of India has contributed for the social and cultural transformation. Families are exposed to intermittent or permanent migration. As a result of which family dynamics is undergoing drastic changes resulting in intergenerational gaps on the one hand, and emerging new challenges in elderly care and protection support system. Both rural and urban communities are encountered with different challenges and responses to meet the elderly care, support and protection needs. Vulnerability, maladjustment, abuse, harassment and abandonment of elderly are the major issues to deliberate and respond.
