1. Professor: 01

An eminent scholar with Ph.D. qualification in relevant discipline and published work of high quality, and major contribution to the below mentioned thrust areas, actively engaged in research with evidence of published work with a minimum of 10 publications as books and/or research/policy papers.

A minimum of ten years of teaching experience in university/college, and/or experience in research at the University/National level institutions, including experience of guiding candidates for research at doctoral level.

Contribution to educational innovation, design of new curricula and courses, and technology – mediated teaching learning process.

A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in UGC Regulations in Appendix III.

OR

An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the relevant Disciplines to be substantiated by credentials.

Superannuated Professors who are not above 65 years could also be considered for the post. Re-employment rules of Govt. of India will be admissible

Age : Not ordinarily below 50 years and maximum upto 65 years as on closing date of application.

Tenure of Appointment: 3 years subject to UGC direction, from time to time.

2 LIBRARIAN

Essential qualification :-

A Master's Degree in Library Science /Information Science / Documentation with at least 55% marks or its equivalent grade of B in UGC seven-point scale and a consistently good academic record.

- i. At least 13 years as Deputy Librarian in a University Library or Eighteen years' experience as a college Librarian.
- ii. Evidence of innovative library service and organization of published work.

Desirable qualification :

A M.Phil. / Ph.D. degree in Library Science / Information Science / Documentation / Archives and Manuscripts-Keeping.

Age limit for direct recruits: Below 56 years

Age limit for deputation: Below 58 years

3 DEPUTY REGISTRAR

Essential qualification:

- (i) Master's degree with at least 55% of the marks or its equivalent grade in a point scale wherever grading system is followed.
- (ii) 9 years' experience as Assistant Professor in the AGP of 6000 and above with experience in educational administration, **or**
- (iii) Comparable experience in research establishment and/ or other institutions of higher education, **or**
- (iv) 5 years of administrative experience as Assistant Registrar or an equivalent post.

- (i) A Master's degree in library science/information science/ documentation Science or an equivalent professional degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and a consistently good academic record with knowledge of computerization of library.
- (ii) Qualifying in the National Level Test conducted for the purpose by the UGC or any other agency approved by the UGC.
- (iii) However, candidates, who are, or have been awarded Ph.D. degree in accordance with the "University Grants Commission (Minimum Standards and Procedure for award of Ph.D. Degree), Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of University Assistant Librarian/College Librarian.

Desirable qualification:

PG Diploma in Library Automation and Networking or PGDCA or equivalent.

OR

Master's degree in Library & Information Science with PG Diploma in Computer Application with 55% or equivalent grade.

Desirable qualification: 2 years of relevant experience.

Age limit for direct recruits : Not exceeding 35 years

Method of recruitment : Direct recruitment

9 MEDICAL OFFICER

MBBS recognized by Medical Council of India.

Desirable qualification:

- i) Post-graduate Medical Qualification from an Institution recognised by the Medical Council of India.
- ii) Relevant working experience of 2 years in Government Hospital or Hospital recognized by the Government.

GENERAL INFORMATION

1. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed, or by any other condition that may deem fit. It would be open to

the University to consider the names of suitable persons who may not have applied, but recommended by experts in their respective fields.

2. The statutory provision for relaxing of age, experience etc. prescribed in case of the candidates belonging to SC/ST/OBC/PWD categories will be made applicable to them as per UGC/GOI norms in force at time of interview. Candidates are advised to check UGC and other relevant websites for updated information.
3. The panel of selected waitlisted candidates will be valid for one year from the date of approval of competent authority and University shall make appointments on consequential/ new vacancies.
4. Outstation unemployed candidates belonging to SC/ST categories called for interview will be paid by the shortest route return single second-class railway fare towards journey expenses on production of ticket numbers/proof as provided under Government of India rules.
5. Canvassing in any form on behalf of any candidate will disqualify such candidate.
6. Selection will be made on the basis of candidates' previous record their performance in the test/ interview (wherever applicable).
7. The in-service candidates should apply through **proper channel, failing which the application is liable to be rejected.**
8. The conditions of age will be relaxed for in-service candidates, by the competent Authority in consonance with the orders/guidelines issued by the Govt. of India/UGC from time to time.
9. Separate application should be submitted for each post with prescribed fee.
10. Experience and qualifications will be reckoned as on the last date of receipt of applications.
11. Applications incomplete in any respect, will not be considered.
12. No interim queries regarding test/interview/selection will be entertained.
13. University reserves the right not to fill up any of the vacancies advertised, if the circumstances so warranted without giving any reason.
14. Those candidates who applied earlier will have to apply again / afresh in response to this advertisement for his/her candidature to be considered.

15. New pension scheme in accordance with the O.M.No. 1(13)EV/2001, dated 15/03/2004, Govt. of India, Ministry of Finance, Department of Expenditure, will be applicable with subsequent amendments.

16. Conditions of deputation, wherever applicable :

In case the appointment is made on deputation basis, the incumbent may be allowed to continue for a maximum period of five years or till he/she attains the age of superannuation prescribed for that particular cadre, whichever is earlier. The appointment on deputation may be made initially for a period of two years which may be extended on yearly basis up to a maximum period of five years subject to satisfactory performance, good demeanour and high integrity. The University, however, shall have the right to repatriate the incumbent any time even before the prescribed period if his/her performance, integrity or conduct is found to be unsatisfactory in the opinion of the competent authority at any stage or in the event of the repatriation of the employees against whose vacancy the deputationist employee was working. Ordinarily, no deputationist employee shall be absorbed in any post of the University on completion of the period of his/her deputation. If, it is decided in the interest of the University to absorb any such employee, the Administration of the University may take up the matter with his/her parent organization for concurrence after obtaining the option of the deputationist employee concerned. After obtaining the consent of the parent organisation, the case shall be placed before the Executive Council for a final decision. If he/she is absorbed in the University, he/she will be placed at the bottom of the seniority of that particular grade as per the Government of India orders/guidelines.

17. In case of any disputes/suites or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Kalaburagi, which is the Head quarter of the University.

18. Errors and omissions are subject to corrections.

19. Applications received after the last date and without complete information or without requisite fee will be summarily rejected. **The University will not be responsible for any postal delay.**

20. Application fee once paid shall not be refunded under any circumstances.
