
: IMPORTANT NOTE :

1. The provisionally eligible candidates may be called for interview as per the University rules. Intimation will be sent through the registered e-mail only, please visit CUK Website regularly for further updates.
2. The eligibility of the candidates is subject to production of all the original, recent, relevant certificates and documents as per UGC 2018 regulations and GOI norms. Failing which the applicant shall not be allowed to attend the interview.
3. The candidates should bring three copies of the printout of his/her application form during the interview.
4. The eligibility for UR post is considered for SC, ST and OBC candidates only if the separate applications are submitted as per general information in notification clause No. 17, 21 & 22.

5. The eligibility to the minimum qualification and other terms and conditions as per UGC norms (UGC 2018 & AICTE 2019 regulation) shall be strictly followed.
6. Those candidates having Ph.D. and PG from Foreign Universities need to provide the equivalence certificates from AIU (www.aiu.ac.in/evaluation).
7. The unemployed candidates (SC/ST/PWD) are required to produce the journey tickets for claiming travelling charges as per notification referred to above.
8. The past experience is considered as per UGC regulation 2018 (point No. 10) if proper certificate of experience containing details of salary drawn/ scale/ selection procedure/ NOC and duration of employment etc. is enclosed.
9. The research papers are considered only wherever full text papers are enclosed with proof provided by the candidates that they are published as per UGC norms. The University reserves the right to follow the UGC direction given time to time regarding the quality of publications at any stage of recruitment process.
10. If any candidate has got eligibility on inadvertently wrong information/data than entitled, he/she should bring the same to the notice of the undersigned immediately.
