REGISTRAR

1. SCOPE OF WORK

- a. To ensure providing duly licensed and experienced drivers and good vehicles to ensure continued and un-interrupted vehicle services in accordance.
- b. To ensure that all drivers provided by your firm are trained on driving, safety, behaviour and hygiene aspects.
- c. To maintain the contracted vehicles in good operable conditions in accordance with good industrial practices and operation and to ensure that safety and security of staff on the hired vehicles is maintained at all times.
- d. To be ready to bear the cost of fuel, vehicle maintenance including breakdowns, man power, washing service and other required services etc. during the time or period of hiring of the particular vehicles.
- e. To be ready to provide vehicles of any type at any point of time as and when required by the University Authority.

TERMS & CONDITIONS

- I. Central University of Karnataka reserves the right to terminate the contract without assigning any reason by giving the notice of 30 days to the contractor.
- II. Vehicles provided by the Firm/Agency should bear commercial Registration Numbers and should have comprehensive insurance and Drivers so provided with the vehicles shall have commercial LMV Driving License.
- Ill. The vehicles should confirm to the Pollution norms pr scribed, if any, by the Transport Department of Government.
- IV. The vehicle and Driver shall remain available all the time as per Duty Roster and shall not leave place of duty without prior permission.
- V. The contractor shall be responsible for total maintenance of the vehicles provided by the firm. All the vehicles provided should be in good running condition.
- VI. In case of breakdown of any vehicle, the contractor shall replace the breakdown vehicle within one hour failing which the Department has the right to hire vehicle from any other sources at the expense of the contractor.
- VII. The contractor will maintain separate log books for each vehicle which will also be verified/countersigned by the concerned officer.
- VIII. The bills in triplicate should be made date-wise by the contractor and should be submitted to the Vehicle Section, Central University of Karnataka on monthly basis.
 - IX. Central University of Karnataka will deduct Income Tax and VAT at source as

- per rule at the time of payment of bill.
- X. No separate rate will be allowed irrespective of any kind of fuel used to run vehicles.
- XI. Normal Duty hours from 9.00 AM to 8.00 PM every day. No overtime charge will be allowed during normal duty hours.
- XII. The contract shall be governed by the Laws and Procedures established by the Government of India and subject to exclusive jurisdiction of Court in Kalaburagi only.

3. General Conditions:

- (a) Expression of Interest (EOI) document can be seen and downloaded from the University web site: www.cuk.ac.in from the date of publication of this EOI up to 31.08.2018 upto 3.00pm. No EOI document will be sold by the University.
- (b) Expression of Interest (EOI) form downloaded from University website should be accompanied with a non-refundable processing fee of Rs. 5,000/- (Rupees two thousand only) in the form of Demand Draft drawn in favour of Central University of Karnataka" payable at Kalaburagi. In case of non-submission of the fee, the EOI shall be summarily rejected.
- (c) The bidder has to submit a declaration on the Company's letter head that no amendments have been made in the EOI document downloaded from University website at the time of submission of the EOI document.
