
**Resolutions:**

4. The committee unanimously recommended to delete the following specifications in the tender document (the points are from Sl no. 11 in **Technical Specifications** of the tender document).
  - a. Annual health check-up.
  - b. Minimum 10% discount on pharmacy products, FMGC products and diagnosis tests.
  - c. The policy shall be implemented within 30 days from the date of entering contract.
  - d. No claim bonus, if any.
5. The committee recommended to add "Insurance coverage is from the day one and it shall cover all preexisting illness and disease etc. from the date of payment of premium.
6. The committee recommended to limit 4% of the sum assured per day for room rent.

7. The committee Recommended to amend "Coverage for Alternative treatments" as Coverage for Alternative treatments in Govt. approved hospitals.
